Dear Street Fair Vendor,

We're excited to send you our 2010 Potato Days Street Fair Brochure. We hope that you choose to be part of the Barnesville Potato Days Festival to be held on Friday, August 27 and Saturday, August 28. In 2009 we had over 16,000 people come to Potato Days! That is a record attendance and we are looking forward to another great year!

Please be reminded that the Street Fair hours are on **Friday, August 27 from 12:00 Noon to 8:00pm and on Saturday, August 28, from 9:00am to 4:00pm. You MUST be off the street by 5:00 p.m. on Saturday!!!** We ask that you be set up prior to opening time and remain set up until the fair's close. Security will be provided from Friday 8:00 p.m. to Saturday 8:00 a.m.

We will once again use the same rules as in 2009. Whereas, some of the blocks will be for those vendors that wish to have a trailer or vehicle in their space and other blocks will be just for booths. If you have been a past vendor we will try very hard to accommodate you in your previous space. But please note, that some spaces will not allow trailers or vehicles to be parked on the streets as they were before. Therefore, you may want to request a different location for 2010. Please see the enclosed map for particular areas where trailers or vehicles will be allowed. Numbers will be assigned and given out at registration. You may request a certain block (ie block 1, block 2, block 3); please note that block 3 will be the only spaces that allow trailers and/or vehicles.

Acceptance into the Potato Days Street Fair is once again a **FIRST-COME-FIRST-SERVE PROCESS**. Once we have received your application, an e-mail (please provide on the application form for faster service) or post card will be sent to you.

As in prior years you will be asked to register the morning of the Street Fair and you will then receive your map with your location of all vendors. No maps or information are able to be given out prior to registration on Friday morning.

It is advised that exhibitors carry their own insurance. Neither the City of Barnesville nor the Potato Days Festival will be responsible for accidental loss or damage of any kind. Individuals are responsible for collecting their own sales tax. Also, please come prepared to protect your merchandise in case of inclement weather which includes tarps, weights and tie downs; note that nothing can be drilled into the pavement. A waiver is included at the bottom of the application as well as an Operator Certificate of Compliance. **Please return all to the Potato Days Office** in order for your application to be processed.
